This reprogramming action transfers funds between appropriations for proper execution. The reclassification is required to execute funds properly in accordance with congressional intent. These actions are determined to be necessary in the national interest. These actions do not change the purpose for which the funds were originally appropriated. This reprogramming action meets all administrative and legal requirements, and none of the items has been previously denied by the Congress.

This reprogramming action realigns \$60.000 million within the Aircraft Procurement, Air Force 23/23, appropriation to mitigate the impact of revised economic assumptions on that appropriation. The funds being realigned were previously transferred to the account for such purposes pursuant to section 8121 of the Department of Defense Appropriations Act, 2023, division C of Public Law 117-328.
