This reprogramming action transfers funds between appropriations for proper execution. The reclassification is required to execute funds properly in accordance with congressional intent. These actions are determined to be necessary in the national interest. These actions do not change the purpose for which the funds were originally appropriated. This reprogramming action meets all administrative and legal requirements, and none of the items has been previously denied by the Congress.

This reprogramming action transfers \$764.157 million from the Shipbuilding and Conversion, Navy, 26/30, appropriation to the National Sea-Based Deterrence Fund, 26/30, appropriation for proper execution. The funds are appropriated in division A of Public Law 119-75, the Department of Defense Appropriations Act, 2026 and are transferred pursuant to subsection (d) of section 2218a of title 10, United States Code.
